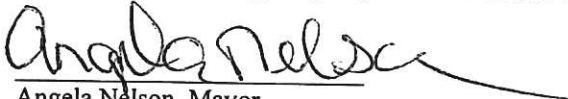
1. **CALL TO ORDER.**
